



TERMS & CONDITIONS

Reservations for this event are available exclusively through Eagles' Wings Ministry Travel (hereafter known as "EWMT"). All prices, penalties and change fees are quoted per Attendee based on double occupancy (two persons per room). Sites, artists, speakers, fees and/or schedules are subject to change. Carefully review the Terms and Conditions included with your invoice/statement and all documentation you receive in connection with your registration for the tour/event. The invoice/statement which you, as an attendee at the tour/event ("Attendee"), will receive confirming your reservation is an agreement between EWMT and Attendee.

PRICING: All prices quoted are in U.S. dollars and are based on the current rate of international exchange between the U.S. dollar and foreign currencies at time of publication. Whenever possible, EWMT obtains price guarantees from suppliers. However, depending upon the strength of the U.S. dollar and the fluctuating cost of fuel, supplier expenses, governmental fees and other taxes, published prices are subject to change without notice and will be chargeable to the Attendee up to the time of departure.

NOT INCLUDED IN PRICES Passport costs, air travel to/from Tel Aviv outside of gateway cities provided, pre/ post hotel nights, additional hotel nights due to travel connections, meals not specifically detailed in the tour/event itinerary, items of a personal nature (such as laundry, room service at hotel, meals in transit, phone calls, internet), etc.

COMPLETE EVENT CANCELLATION In the event Awake Jerusalem elects to cancel the tour/event in full, Awake Jerusalem will work to refund attendees and/or offer alternate arrangements. If, however, circumstances outside of the control of EWMT/Awake Jerusalem make it impossible, impractical or unsafe to conduct the tour/event as scheduled, then EWMT/Awake Jerusalem may elect to re-schedule the tour/event to an alternate date within one (1) year of the currently scheduled date of the tour/event. In the event of such a rescheduling of the tour/event, EWMT/Awake Jerusalem may either refund the Attendee's Registration Fee or credit the Registration Fee toward the rescheduled tour/event, in which case EWMT/Awake Jerusalem shall not be obligated to make any further refund of monies to the Attendee. No reimbursement will be paid by EWMT or Awake Jerusalem to Attendees for air tickets, additional hotel nights, etc.

PROOF OF CITIZENSHIP A valid passport is required for all Attendees, including children, and must remain valid for six (6) months beyond the completion of your travel. For U.S. citizens and residents, more information is available online at www.travel.state.gov/passport or by calling the National Passport Information Center at 877-487-2778. Non-U.S. citizens and U.S. citizens originating from outside the U.S. should consult their country's embassy regarding specific requirements for entry into each and every country of destination. Your passport name must match the name on your reservation and airline ticket or you may be denied travel. It is the personal responsibility of each Attendee to fully comply with all immigration & documentation requirements.

PHYSICAL REQUIREMENTS There may be restrictions imposed by the Travel Suppliers (air carrier, tour operator, etc.). Activities for the tour/event require you to be in good health and able to climb stairs without assistance, walk at a modest pace for a few miles per day on uneven terrain and be able to transport your own luggage. Because facilities in sites around the world vary significantly, accommodations for Attendees with mobility limitations (wheelchair, walker, cane, etc.) may not be available. If you have a medical condition (mobility limitations, pregnancy, etc.) or use medical equipment which could affect your travel, please consult your physician and notify EWMT so we can inform you of possible travel restrictions.

IMAGE, SOUND AND CONTACT INFORMATION AUTHORIZATION AND RELEASE Awake Jerusalem has the exclusive right to all audio recordings, video recordings, photographs, film and any other tangible medium record of activities during the tour/event. Your registration for the tour/event serves as your authorization and grant of permission for you and all persons on your reservation to be photographed, audio and/or video recorded in conjunction with the tour/event and you hereby release Awake Jerusalem and any licensee from any liability, restrictions, conditions or any compensation for obtaining and using these images and sounds. In addition, registration for the tour/event constitutes consent from you and all persons on your reservation for Awake Jerusalem and any licensee to use the contact information provided for purposes of advertising and marketing future events, with an opportunity to opt out of receipt of these materials through written notice to Awake Jerusalem.
